

Eligibility

The Fine Arts Show is open to all artists who produce original art. Fine art mediums include: glass, wood, oils, watercolor, mixed media, pencil, pastels, pottery, jewelry and photography.

Policy

The Harvest Festival Fine Arts Show will only accept artists' handmade original art work. No work can be made from a kit or pre fabricated. The festival committee reserves the right to refuse exhibition works not consistent with the quality and cohesiveness of the submitted images.

Exhibit Hall

The Harvest Festival Fine Arts Show is an indoor event. Booth spaces are 10'x 10'. Tables and chairs are available. Artists may set up on Friday, October 4th from 10am-5pm CST and Saturday, October 5th beginning at 6am CST. Booth sitters will be available.

Artists Submissions

Each artist must submit three to five digital images best representing their work, and at least one booth image, on a CD. All images must be in JPEG format, sized to at least 1200-2400 dpi. Each image must be titled as follows: First initial, last name, medium.jpeg. For example: j smith-oil.jpeg.

Label CD with your name, phone number, e-mail address and medium (please, no paper labels). Send the entry form, \$20 jury fee, and image CD to: Harvest Festival c/o Portage Parks Department. 2100 Willowcreek Road, Portage, IN 46368. Make checks payable to: Portage Parks Department and include your phone and license numbers on the check. We can not process any checks without that information. CD's will not be returned unless you provide a self addressed stamped envelope. Notifications will be sent via e-mail. There will be a waiting list available.

Artists

Artists are encouraged to demonstrate their craft during the show. Refreshments and a light lunch will be provided.

Advertising

Advertising will include the Northwest Indiana, Chicago, and Michigan areas, the internet, print media, radio and flyers.

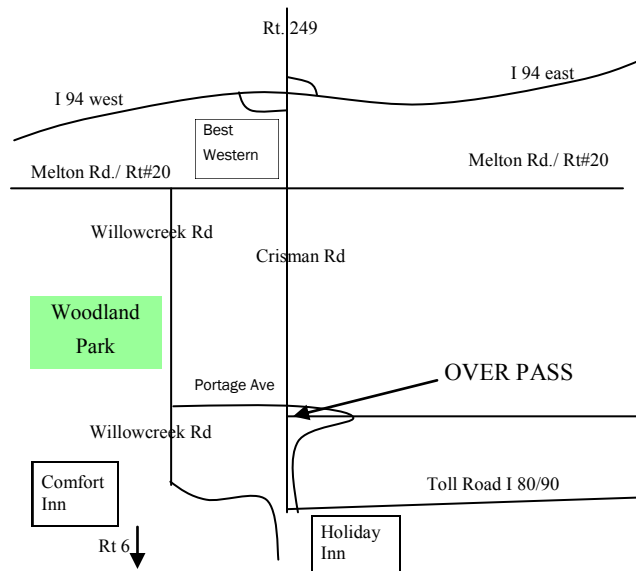
